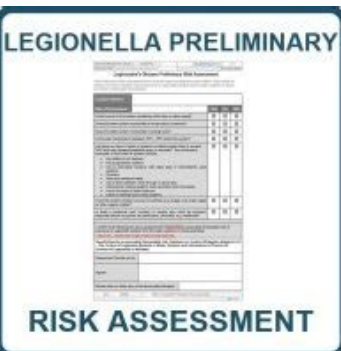
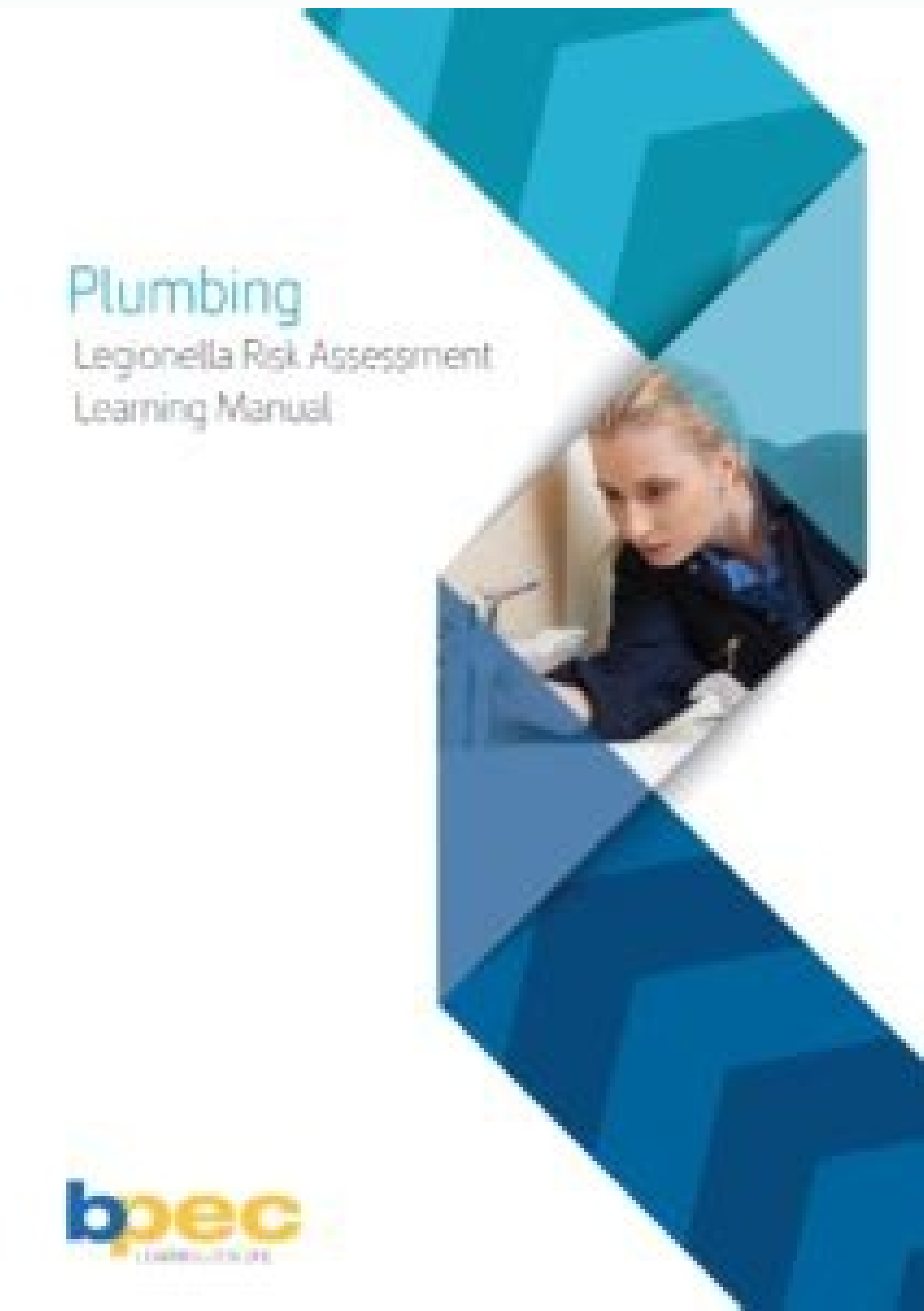
The level of risk of an activity is dependent upon two factors, the probability that harm will occur and the severity of that harm.

Confirmed cases, usually through the testing of a urine sample, can be effectively treated with a course of antibiotics. We accompany dental care professionals we should be aware that Legionella thrives between 20°C to 45°C, but is happier and more virulent at 37°C. Legionella outbreaks continue to increase, with 400-550 cases reported in recent years in England and Wales alone. The highest risk are those over 45 years old (Gulp!), smokers and drinkers, those with immunity with disabilities and patients who may be suffering from respiratory or kidney disease. This bacterium has been opened up to the respiratory system of a susceptible host through small droplets of contaminated water that has been inhaled. You may be familiar with Legionnaires' disease for the first time. The Legionella International Control Guide for Legionella risk assessments for dental practices has been prepared to help those involved in providing Dental services, dentists, dental support staff and service engineers understand more about Legionella risk assessments, including if you need one, and what is involved if you do. In the UK, all dental facilities must have a written and a risk assessment of Legionella in order to assess the risks of Legionella.
